Please note that specific state statutes define these categories somewhat differently and may also have exceptions, limitations or exemptions to the registration/filing requirements that are not reflected in this chart. A careful analysis of each state's law is necessary to determine which requirements may be applicable to your organization.

<sup>\*</sup> Commercial co-venturer (CCV) is not defined in IL law. However, the IL Attorney General has verbally stated that CCVs register as charitable trusts.
